- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本公司證券持有人的名册;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利,例如股息、供股和紅股等;
- 分發本公司及其附屬公司的通訊;
- 編製統計數據和證券持有人資料;
- 披露有關資料以便就權益索償;及
- 與上述有關的任何其他附帶或相關目的及/ 或使本公司及香港股份過戶登記分處能履行 對證券持有人及/或監管機構承擔的責任及 /或證券持有人不時同意的任何其他目的。

# 3. 轉交個人資料

本公司及其香港股份過戶登記分處所持有關證券 持有人的個人資料將會保密,但本公司及其香港 股份過戶登記分處可以在為達到上述任何目的之 必要情況下,向下列任何人土披露,獲取或轉交 (無論在香港境內或境外)有關個人資料:

- 本公司委任的代理人,例如財務顧問、收款 銀行和主要海外股份過戶登記處;
- (如證券申請人要求將證券存於中央結算系統)香港結算或香港結算代理人;彼等將會就中央結算系統的運作使用有關個人資料;
- 向本公司或香港股份過戶登記分處提供與其 各自業務營運有關的行政、電訊、電腦、付 款或其他服務的任何代理人、承包商或第三 方服務供應商;
- 聯交所、證監會及任何其他法定監管機關或 政府部門或遵照其他法例、規則或法規所規 定者;及
- 證券持有人與其進行或擬進行交易的任何人 士或機構,例如彼等的銀行、律師、會計師 或股票經紀等。

# 4. 個人資料的保留

本公司及其香港股份過戶登記分處將按收集個人 資料所需的用途保留證券申請人及持有人的個人 資料。無需保留的個人資料將會根據條例銷毀或 處理。

# 5. 查閱和更正個人資料

證券持有人有權確定本公司或香港股份過戶登記 分處是否持有其個人資料,並有權索取有關該資 料的副本並更正任何不準確資料。本公司和香港 股份過戶登記分處有權就處理任何查閱資料的要 求收取合理費用。

所有查閱資料或更正資料的要求應按招股章程「公司資料」一節所披露或不時通知的本公司註冊 地址送交公司秘書,或向本公司的香港股份過戶 登記分處的個人資料私隱事務主任提出。
